## Drawing Official Rules

1. No purchase necessary to enter and win. Odds of winning depend on number of entries received. Only members of Brazos Valley Schools Credit Union in good standing and persons within the credit union's field of membership 18 or older are eligible to participate in this drawing. Officials, employees, and agents or contractors of the credit union and their family members living in the same household are not eligible. Family members are not eligible if they are dependent upon officials, employees, and agents or contractors of the credit union. There will be one drawing for one prize at each of our ten BVSCU offices.
2. Eligible persons may enter the drawing by the following methods:
  - You will be automatically entered into the drawing when you fund a car loan with the credit union between February 16 and April 16, 2010.
  - To enter manually, without purchase or obligation, eligible persons may submit an original handwritten 3" X 5" card with your name, address, telephone number and date of birth, to 438 FM 1463, Katy, TX 77494. The credit union assumes no responsibility for lost, late, incomplete, stolen, misdirected, illegible, or postage-due mail entries. Manual entries must be received by the close of business on April 16, 2010.
3. One prize at each of our ten offices consisting of a flat screen television will be awarded in a random drawing at each individual office from all eligible entries. The approximate retail value of the prize is \$500. One drawing will be held at each of the credit union's ten offices on or around April 20, 2010. Need not be present to win. All decisions are the sole and absolute discretion of the credit union. Winner will be notified by telephone or U. S. mail. Prize is nontransferable, non-assignable and may not be substituted. The credit union reserves the right to draw for an alternate winner, if the credit union cannot contact and present the prize to the original winner within a reasonable time after the drawing.
